The notes on the search form are numbered in the same order as listed on this form.

1 Contact information

Specify your own reference or file number. The Bureau will use these reference details in all correspondence addressed to you.

The designated contact person is the person within your organization applying for the search. They can provide details if necessary.

2 Bank details

We need your bank account information in order to identify your payment in our financial administration system.

3 Applicant

Please state your name and full address.

4 Representative

Representatives or lawyers specialised in IP are kindly asked to state their details. They can advise on trademark protection, and can deal with all formalities on behalf of the applicant.

If you will be enlisting the services of a representative or a lawyer specialised in intellectual property, they must have a residential or business address within Sint Maarten and they must be recognized by the Bureau.

5 Type of trademark

Word marks

A word mark consists of a letter/letters or a digit/digits or combination of letter(s) and digit(s).

6 Representation of the trademark

Word marks

If you wish us to search for a wordmark, specify the trademark in the box, using block capitals.

7 Class numbers and the description of goods (products) and/or services

Please specify the goods (products) and/or services that apply to the trademark. Goods (products) and services are classified according to an international standard also referred to as the Nice Classification. This classification consists of 45 classes (categories).

Mention the class number(s) for the search and describe the specific goods (products) and services within each class. You can do so in two ways:

1 Use the standard class numbers and standard descriptions, as mentioned in the attachment. For example:
CI 35 Advertising; business management; business administration; office functions.

2 Use the standard class numbers and provide your own description of the goods (products) and/or services. For example:

CI 35 Advertising and advertising consultancy; advertisement design; technical consulting services for advertising campaigns; management of commercial affairs; market research and consultancy; marketing and marketing consultancy services; development, elaboration and implementation of advertising campaigns and other promotional activities and projects.

If your goods (products) and/or services are classified in more than three classes, you will be required to pay a supplementary fee for each additional class.

8 Fees

An overview of our fees is provided as an attachment to these explanatory notes. The fees are exempted from VAT.
